3. The Company will promote and support the involvement of employees, partners, contractors, and other stakeholders in its safety, occupational health, and work environment efforts.

4. The Company recognizes the importance of preventing and assessing the risks of hazards and environmental impacts. It will take all necessary actions to ensure that risk prevention and mitigation systems are applied effectively.
5. The Company will provide training, enhance knowledge, and foster awareness among employees, partners, contractors, and other stakeholders about the risks associated with their work, the importance of occupational health and safety, environmental management, and corporate social responsibility. It also emphasizes the sustainable use of natural resources for maximum benefit.
6. The Company will systematically plan and manage risks to protect the environment and prevent losses resulting from accidents and unforeseen events that may impact life, property, and the environment. It will also establish emergency and crisis management plans to prepare for and address problems or emergencies, ensuring the availability of appropriate resources and regular drills for emergency response procedures.
7. The Company will monitor and evaluate the implementation of safety, occupational health, and work environment policies and the annual work plans to ensure proper execution and the highest efficiency.
8. The Company will communicate and disseminate safety, occupational health, and work environment policies, as well as provide channels for employees, partners, contractors, and stakeholders to raise complaints or suggestions for review or improvement of operations as needed.
